FY 2022 – Governor’s Recommended Budget – online versions

EXECUTIVE SUMMARY

- Page 100 – bullet point titled “Minimum Wage Increase” was deleted. This was sample text that was not removed prior to posting.*
- Page 114 – Under ‘New Federal Funds for Transit’ the amount has been corrected to **\$7.1** million from \$10.0 million. The remaining \$2.9 million of the transfer to RIPTA remains Highway Maintenance Account revenues. *This error is present in the print edition but was subsequently corrected in the online PDF.*
- The table on page A-7 in the Executive Summary inadvertently included a column labeled “Change from Enacted.” The contents of this column duplicated the column labeled “FY 2022.” *This column has been removed from the table in the online PDF but was present in the print edition.*
- On the table on page A-7 in the Executive Summary, the row labeled “Hospitals” should have included the full name of the department of “Behavioral Healthcare, Developmental Disabilities, and Hospitals.” *This error is present in the print edition but was subsequently corrected in the online PDF.*

VOLUME I: General Government & Quasi-Public Agencies

- In the “Quasi-Agency” section, beginning on page 292, reset the header on “THE AGENCY” pages. It was removed in the original version.*
- Page 301 – Replaced “#####” with “**\$10,498,000**” due to the number being truncated in the original version.*

VOLUME II: Human Services

- The entire Executive Office of Health and Human Services section, pages 2-14, have been replaced with pages 2-12. The original had the financial tables from FY2021. *This error is present in the print edition but was subsequently corrected in the online PDF.*

CAPITAL BUDGET

- Page 40 - for Crypt/Cemetery Expansion project - “\$1.8 **million**” (added the word in red)*
- Page 53 – The title of the project ‘Fine Arts Center Renovation & Addition Phases I-b and II’ was formerly ‘Fine Arts Center Renovation & Addition Phase II’ *This error is present in the print edition but was subsequently corrected in the online PDF.*
- Page 54 – In ‘Memorial Union Renovation & Addition,’ the following language has been added: “A further \$5.0 million in RIHEBC bond proceeds would be spent on this project after FY 2026.” *This error is present in the print edition but was subsequently corrected in the online PDF.*

- Page 146 – Schedule 4, Department of Transportation, Providence Viaduct North, Other Highway Funds in FY 2026 was \$57,964,080, is now **\$5,794,080**. *
- Page 240 – footnote was “¹ Assumes issuance of \$12.0 million in FY 2021 at estimated 2.75% interest and 15-year term.” Footnote is now “¹ Assumes issuance of **\$53.6** million in **FY 2022** at estimated 2.75% interest and 15-year term.” *

- Page 244 – For line sequence 4770202, Fund was corrected to **12** from 10. *This error is present in the print edition but was subsequently corrected in the online PDF.*
