Subject Matter of Regulation:

New regulations for the administration of the Local Agriculture and Seafood Act (LASA) grants program (commonly called the LASA grants program). Adopted in 2012, this law allows the Department of Environmental Management to administer a grants program for new farmers and organizations that support the growth, development, and marketing of our agricultural and commercial fishing sectors. It is one of numerous laws adopted by the RI General Assembly in recent years to support the growth of the local food economy.

Describe the Scope and Objectives of the Regulation:

The purpose of these regulations is (a) to accomplish the purposes of RIGL 2-25-1 et seq., (b) to establish the operating procedures for the administration of the Local Agriculture and Seafood Act grant program, and (3) to provide for coordinated administration of any funds from philanthropic or other sources which may be made available to accomplish the purposes of RIGL section 2-25-5 (1)-(5) inclusive and subsection 2-25-7 (b).

Business Industry (s) Affected by the Regulation:

Industries that are potentially positively affected by these regulations include food production, food processing, food distribution, food wholesale, and food retail industries involved in the local food sector (RI based food sector).

Types of Businesses Included in the Industry (s):

Local farming and seafood businesses, businesses selling locally made value-added products (jams, jellies, cheese, etc.), businesses engaged in the distribution and sale of locally grown or produced products.

Total Number of Small Businesses Included in the Regulated Industry (s) *Please see the attached guidance documents for assistance determining the total number of small businesses*:

Because this regulation establishes a process for administering a grant program rather than a permitting and/or required regulatory program, no business is further regulated by its establishment. Rather, the regulation establishes a clear, predictable, and reliable process for a grants program for which non-profit entities or small or beginning farmers may apply to the department of environmental management for a grant to be used to fulfill the purposes of the program as stated in RIGL 2-25-5(3) and 2-25-5(4).

The Department has determined that the best way to assess the positive impact this regulation will have on small businesses is to use USDA census data which provides the number of farming businesses in Rhode Island:

The Department has no way to assess the number of non-profit entities impacted by this legislation.

Because this regulation establishes a process for administering a grant program rather than a permitting and/or required regulatory program, no business is technically 'subject' to the regulation. Rather, the regulation establishes a clear, predictable, and reliable process for a grants program for which the aforementioned businesses, and non-profits, may take advantage.

What is the cost to your agency of establishing and enforcing this regulation?

This regulation will require a .4 FTE for program administration.

It is unlikely that any enforcement monitoring or actions will be required for this regulation, thus the staff time reflected for program administration represents the full cost to the Department.

What would the consequences be if the regulation did not exist?

The Department would not have a clear, publicly vetted, transparent, and reliable process (1) to accomplish the purposes of RIGL, (2) to establish the operating procedures for the administration of the Local Agriculture and Seafood Act grant program, and (3) to provide for coordinated administration of any funds from philanthropic or other sources which may be made available to accomplish the purposes of RIGL section 2-25-5 (1)-(5) inclusive and subsection 2-25-7 (b).
