Amendments to FY 2015 Appropriations Act (14-H-7133)

The Governor requests that several amendments be made to the FY 2015 Appropriations Act, which was submitted to the General Assembly on January 15, 2014. The amendments include changes to appropriation amounts in Article 1, Relating to Making Appropriations in Support of FY 2015, and Article 10, Relating to Making Revised Appropriations in Support of FY 2014.

Also included are minor adjustments to Higher Education sponsored research FTE position authorizations for the University of Rhode Island and the Community College of Rhode Island in Articles 1 and 10 and an adjustment to the Elementary and Secondary Education FY 2015 FTE position authorization to account for the extension of the Race to the Top grant. Also included is a new section in Article 10 requiring the Department of Administration to transfer \$925,419 from the Restoration and Replacement Insurance Coverage restricted receipt account to the state General Fund.

### **ARTICLE 1**, RELATING TO MAKING APPROPRIATIONS IN SUPPORT OF FY 2015

### SECTION 1, APPROPRIATIONS IN SUPPORT OF FY 2015

### **Department of Administration**

Net Zero Change in Human Resources – General Revenues, Page 2, Line 18. The Governor recommends a net zero change for the general revenue human resources clearing accounts that were not included in the original budget submission.

<u>Decrease Planning - Federal Funds, Page 3, Line 14 by \$100,688 from \$12,662,645 to \$12,561,957</u>. The decrease reflects correction of an erroneous double counting of the personnel costs for a new position beginning in FY 2015 for the Division of Planning, which will be responsible for monitoring and coordinating the Hurricane Sandy federal funding.

Decrease Energy Resources - Restricted Receipts, Page 5, Line 28 by \$50,000 from \$5,265,426 to \$5,215,426. Expenditures prior to FY 2014 for Exxon Interest Earnings were erroneously posted to the State Energy Plan. This was discovered in the close-out of the State Energy Plan grant. The Governor recommends shifting restricted receipt funding from FY 2015 to FY 2014 in order to correctly reconcile these costs to the Exxon Interest Earnings line sequence and properly close-out the State Energy Plan grant.

### **Department of Health**

Net Zero Change in the Central Management Program—General Revenues, Page 14, Line 7. The Governor recommends a net zero change in general revenues due to the shift of \$208,240 into a Legislative Grants natural account. This financing was budgeted under an incorrect natural account.

### **Department of Human Services**

<u>Decrease Individual and Family Support - Federal Funds, Page 15, Line 24 by \$4,387,565 from \$117,044,391 to \$112,656,826.</u> This decrease corrects for the erroneous inclusion in the FY 2015 recommendation of the FY 2013 demand side management grant program expenditures.

### Department of Elementary and Secondary Education

Decrease Administration of the Comprehensive Education Strategy - General Revenues, Page 19, Line 9 by \$549,767 from \$19,968,574 to \$19,418,807. The Governor recommends withdrawal of funds for legislative grants to Woonsocket Schools (\$500,000) and East Providence High School (\$50,000), a reduction of

\$550,000, for grants that were intended to be one-time awards in FY 2014. This is offset by an increase of \$233 due to data updates in the Group Home Aid program.

Decrease Administration of the Comprehensive Education Strategy – HRIC Adult Education Grants, Page 19, Line 17 by \$300,000 from \$3,800,000 to \$3,500,000. The Governor recommends decreasing the Human Resources Investment Council Adult Education Grants restricted receipt account. The FY 2014 Budget included a one-time increase of \$300,000 that was carried over to the FY 2015 recommendation in error.

### RI Higher Education Assistance Authority

Increase Federal Funds - WaytogoRI Portal, Page 24 Line 22 by \$262,919 from \$650,000 to \$912,919 and decrease Federal Funds, Page 24, Line 21 by \$262,919 from \$11,180,967 to \$10,918,048. The Governor recommends shifting \$262,919 of federal funds from the RIHEAA Administration Student Loan Program account to the WaytogoRI Web Portal account. For purposes of clarity, the Governor recommends reflecting all WaytogoRI Web Portal expenditures in the same account. This is part of an initiative to improve the presentation of financial data with the goal of making program expenditures more transparent.

Increase Other Funds - Tuition Savings Program — Needs Based Grants and Work Opportunities, Page 24, Line 29 by \$1,000,000 from \$6,500,000 to \$7,500,000. The Governor recommends adding \$1.0 million of other funds to include funding for the Academic Promise Program in FY 2015. Funding for the program was inadvertently omitted in the Governor's FY 2015 budget.

### **Department of Environmental Management**

Net Zero Change in the Natural Resources – Federal Funds, Page 30, Line 25. This change reflects a federal shift of \$570,000 from Wildlife Habitat Development to Bureau of Outdoor Recreation Projects and Atlantic Coast Co-op Statistics.

Increase Environmental Protection - Federal Funds, Page 31, Line 11 by \$80,000 from \$10,281,483 to \$10,361,483. This change consists of an increase of \$80,000 for a wastewater study under the Floods Disaster Recovery Grant. There is also a federal shift of \$220,000 from Non-Point Source Pollution to National Pollution Discharge and Groundwater - 106.

### **Coastal Resources Management Council**

Decrease Federal Funds, Page 31, Line 21 by \$28,470 from \$1,802,613 to \$1,774,143. The Governor recommends this reduction due to a change in the time period available for the expenditure of the R.I. Aquatic Invasive Species grant from three to five years to one year. The funds will not be available after June 30, 2014. The overall grant total of \$110,530 has not changed.

### SECTION 10, FY 2015 FTE POSITION AUTHORIZATION

Page 35, Line 34: Increase the Elementary and Secondary Education's FTE position authorization level from 154.9 to 161.4, or an increase of 6.5 FTE positions. This would accommodate a no-cost extension to July 1, 2015 granted for the Race to the Top grant, which originally was set to expire September 30, 2014. Prior to this amendment, 5.5 FTE positions of the authorization level were attributed to this grant; the Department requests this to be restored to 12.0 FTE positions, which are currently filled and supported by this grant.

<u>Page 36, Line 7:</u> Increase the University of Rhode Island's third-party funds FTE position authorization from 501.2 to 573.8, or an increase of 72.6 FTE positions. This amendment would restore the third-party funded FTE position authorization to the FY 2014 enacted level of 593.2 FTE positions, less the 19.4 FTE positions added to Gen Ed and the Dining auxiliary. This change does not authorize additional FTE positions, but rather increases the number that can be supported by third-party funds within the overall authorization.

Page 36, Line 13: Increase the Community College of Rhode Island's third-party funds FTE position authorization from 58.7 to 94.0, or an increase of 35.3 FTE positions. This amendment would restore the third-party funded FTE position authorization to the FY 2014 enacted level of 100.0 FTE positions, less the 6.0 FTE positions added to Gen Ed. This change does not authorize additional FTE positions, but rather increases the number that can be supported by third-party funds within the overall authorization.

### **ARTICLE 10**, RELATING TO MAKING REVISED APPROPRIATIONS IN SUPPORT OF FY 2014

### SECTION 1, REVISED APPROPRIATIONS IN SUPPORT OF FY 2014

### **Department of Administration**

Increase Office of Management and Budget - Restricted Receipts, Page 69, Line 19 by \$50,000 from \$265,939 to \$315,939. The increase reflects a grant from the Rhode Island Foundation that was not included in the original budget submission for the Statewide E-permitting project. The grant is being used to purchase equipment and training for the Building Code Commissioner and State Fire Marshall's Office to support the E-permitting project.

Decrease Auditing - Other Funds, Page 69, Line 28 by \$25,000 from \$25,000 to \$0. The decrease reflects a change in the presentation of how the Bureau of Audits will be reimbursed by the Rhode Island Emergency Management Agency for work

completed in FY 2014. The reimbursement will be done through a transfer of costs from the Bureau to the EMA federal grant.

Net Zero Change in Human Resources - General Revenues, Page 69, Line 31. The Governor recommends a net zero change for the general revenue human resources clearing accounts that were not included in the original budget submission.

Increase Energy Resources - Restricted Receipts, Page 73, Line 13 by \$50,000 from \$5,642,539 to \$5,692,539. Expenditures prior to FY 2014 for Exxon Interest Earnings were erroneously posted to the State Energy Plan. This was discovered in the close-out of the State Energy Plan grant. The Governor recommends shifting restricted receipt funding from FY 2015 to FY 2014 in order to correctly reconcile these costs to the Exxon Interest Earnings line sequence and properly close-out the State Energy Plan grant.

### **Department of Health**

Net Zero Change Central Management – General Revenues, Page 81, Line 15. The Governor recommends a net zero change in general revenues due to the shift of \$208,240 into a Legislative Grants natural account. This total was budgeted under an incorrect natural account.

Increase Community and Family Health and Equity - Federal Funds, Page 82, Line 7 by \$3,309,979 from \$37,249,244 to \$40,559,223. The Governor recommends increasing federal funds to accommodate projected spending in the ACS MCH Home Visiting Expansion Grant, Wisewoman Grant, and Child Care Support Network Grant. Funding for these grants is recommended to increase \$2,939,425 to \$3,159,577, \$265,554 to \$378,044, and \$105,000 to \$405,000, respectively.

<u>Increase Community and Family Health and Equity - Federal Funds - Stimulus, Page 82, Line 8 by \$651,950 from \$366,227 to \$1,018,177.</u> The Governor recommends increasing federal stimulus funds to accommodate projected spending in the Race to the Top Early Learning Challenge Grant. Funding for this grant is recommended to increase \$651,950 to \$1,017,581.

Increase Infectious Disease and Epidemiology - Federal Funds, Page 82, Line 16 by \$986,541 from \$4,390,718 to \$5,377,259. The Governor recommends increasing federal funds to accommodate projected spending in the Epidemiology & Lab Capacity for Infectious Diseases Grant and the HIV Prevention Grant. Funding for these grants is recommended to increase \$386,439 and \$600,102 to \$1,359,423 and \$2,281,356, respectively.

### **Department of Human Services**

<u>Increase Central Management - Federal Funds, Page 82, Line 23 by \$579,431 from \$4,284,104 to \$4,863,535.</u> This increase accommodates payments that were made

in FY 2014 for expenses incurred in FY 2013 through the Community Services Block Grant that were not included in the Governor's FY 2014 supplemental budget recommendation.

Decrease Individual and Family Support - Federal Funds, Page 82, Line 32 by \$4,212,780 from \$129,899,982 to \$125,687,202. This adjustment corrects for the erroneous inclusion in the FY 2014 recommendation of the FY 2013 demand side management grant program expenditures (a reduction of \$4,387,565), partially offset by an increase of \$174,785 to the Food Stamp Employment Program.

Decrease Veterans' Affairs - Federal Funds, Page 83, Line 8 by \$408,414 from \$9,083,976 to \$8,675,562. This decrease removes duplicative funding for Veterans' Cemetery maintenance from the FY 2014 revised recommendation.

### **Department of Elementary and Secondary Education**

Increase Administration of the Comprehensive Education Strategy - General Revenues, Page 86, Line 7 by \$15,052 from \$19,589,216 to \$19,604,268. The Governor recommends increasing general revenues by \$15,052 from an increase of \$60,000 due to data updates in the Group Home Aid Program, offset by a reduction of \$44,948 in the Non-public Textbook Program.

Increase Administration of the Comprehensive Education Strategy - Federal Funds, Page 86, Line 8 by \$72,629 from \$198,644,718 to \$198,717,347. The Governor recommends increasing federal funds to include additional carry forward financing, \$7,120 in the Special School Milk Program and \$65,509 in the Summer Food Service Program.

### **Public Higher Education**

Increase Office of Postsecondary Commissioner - Federal Funds, Page 87, Line 31 by \$42,237 from \$5,032,194 to \$5,074,431. The Governor recommends increasing federal funds in the Office of Postsecondary Education. This increase is for a new federal grant award for the Statewide Data Systems program.

### RI Higher Education Assistance Authority

Increase Other Funds - Tuition Savings Program — Needs Based Grants and Work Opportunities, Page 91, Line 5 by \$800,000 from \$8,000,000 to \$8,800,000. The Governor recommends adding \$800,000 of other funds to include funding for the Academic Promise Program in FY 2014. Funding for the program was inadvertently omitted in the Governor's FY 2014 revised budget.

Net Zero Change Federal Funds, Page 91, Line 2. The Governor recommends shifting \$161,118 of federal funds from the RIHEAA Administration Student Loan Program account to the WaytogoRI Web Portal account. For purposes of clarity,

the Governor recommends reflecting all WaytogoRI Web Portal expenditures in the same account. This is part of an initiative to improve the presentation of financial data with the goal of making program expenditures more transparent.

### **Historical Preservation and Heritage Commission**

Increase Restricted Receipts, Page 91, Line 12 by \$37,500 from \$420,320 to \$457,820. The Governor recommends increasing the Historical Preservation Revolving Loan Fund – Interest Revenue by \$37,500 to reflect previously unanticipated receipts in FY 2014.

### **Department of Corrections**

Increase Central Management - Federal Funds. Page 92, Line 8 by \$43,079 from \$611,699 to \$654,778. The Governor recommends increasing federal funds by \$43,079 to reflect expenditure of the balance of funds available for the WINFACTS Probation & Parole Rewrite Program.

Insert a new line entitled "Central Management - Restricted Receipts", Page 92, After Line 9, \$344,240. The Governor recommends the addition of \$344,240 in restricted receipt expenditure from Google Settlement Funds from the State Police to establish connections between municipal law enforcement agencies and the WINFACTS program, an internet version of the inmate tracking system for use by local police departments and the State Police.

### **Judiciary**

Increase Family Court - Federal Funds, Page 93, Line 34 by \$346,823 from \$1,733,948 to \$2,080,771. The Governor recommends adding \$183,334 for a new Family Treatment Drug Court grant for children whose health and welfare is affected by parents appearing before the Court with substance abuse issues, to be used by Judiciary staff to better coordinate services for these children. The Governor also recommends \$125,489 for a new Juvenile Justice Mental Health Court grant that will allow Judicial staff to better coordinate access to mental health treatment services for certain individuals appearing before the Court. The Governor also adds a total of \$38,000 to the Juvenile Justice and Victims of Crime grants to accommodate financing requirements for Grant Project Specialists hired under the ADIL master price agreement.

### Military Staff

Net Zero Change in Emergency Management - Federal Funds, Page 94, Line 34. The Governor recommends several federal grant adjustments to accommodate expected disbursements in the current year. The 2010 Homeland Security grant is reduced by \$1.0 million, the Tropical Storm Irene Hazard Mitigation grant is

reduced by \$500,000, and the 2012 Hurricane Sandy is reduced by \$1.0 million. These reductions are offset by increase of \$2.0 million in the Nemo Blizzard 2012 grant to accommodate expected FEMA reimbursements to communities and other qualified applicants. Three new grants totaling \$500,000 are also recommended including \$125,000 for the 2012 Pre-Disaster Mitigation award, \$100,000 for the new 2013 State Homeland Security grant and, \$275,000 for a new grant awarded by the federal Department of Commerce for state and local integration with the nationwide public safety broadband network.

### **Department of Public Safety**

Increase State Fire Marshal - Federal Funds, Page 95, Line 16 by \$205,000 from \$316,668 to \$521,668. The Governor recommends increasing federal funds in the State Fire Marshal Program. This increase is for a new federal grant award for the State Homeland Security Fire Marshal Bomb Squad program.

Increase State Police - Federal Funds, Page 95, Line 32 by \$90,913 from \$4,898,107 to \$4,989,020. The Governor recommends increasing federal funds in the State Police Program. This increase is for a new federal grant award for the Neighborhood Community Investment Program (NCIP).

### **Department of Environmental Management**

Increase Natural Resources - Federal Funds, Page 96, Line 28 by \$447,700 from \$25,760,194 to \$26,207,894. This change consists of increases of \$51,300 for Forest Legacy Administration and \$76,400 for the Planning Challenge Grant, which were both erroneously excluded from the revised budget recommendation. There is an increase of \$320,000 for the Enforcement of Pesticide Regulations grant to account for unexpended grant awards from FY 2009, 2010, 2011, and 2012. There is also a federal shift of \$350,000 from the Wildlife Habitat Development Program to the Wildlife Restoration Program in the Bureau of Natural Resources.

<u>Increase Other Funds – DOT Recreational Projects, Page 96, Line 31 by \$521,077 from \$1,094,278 to \$1,615,355</u>. This increase is related to additional expenses associated with creating and maintaining recreation trails in the state, as well as replacing the Lewis City Bridge in Arcadia Management Area and Galilee Ferry Terminal Safety Improvements.

Increase Environmental Protection - Federal Funds, Page 97, Line 14 by \$840,000 from \$9,847,442 to \$10,687,442. This change consists of increases of \$600,000 for Non-Point Source Pollution, which will be used to enable cities and towns to be paid under the Performance Partnership Grant awards; \$220,000 for the Superfund National Priority List to accommodate vendor contractual expenses in the grant award for Interim Remedial Action at the Centerdale Manor in North Providence; and \$20,000 for a wastewater study under the Floods Disaster Recovery Grant.

There is also a federal shift of \$100,000 from the Diesel Emissions Programs to the Non-Point Source Pollution and National Pollution Discharges Programs.

### **Coastal Resources Management Council**

Decrease Federal Funds – Stimulus, Page 97, Line 25, by \$147,547 from \$699,769 to \$552,222. The Governor recommends this reduction to reflect a revised expenditure level, representing completion of the Fish Passage Restoration project.

Increase Federal Funds, Page 97, Line 24 by \$28,470 from \$1,635,263 to \$1,663,733. The Governor recommends this increase due to a change in the time period available for the expenditure of the R.I. Aquatic Invasive Species grant from three to five years to one year. The funds will not be available after June 30, 2014. The overall grant total of \$110,530 has not changed.

### **Department of Transportation**

Increase Central Management - Federal Funds, Page 97, Line 33 by \$3,400,000 from \$7,999,987 to \$11,399,987. The Governor recommends increasing federal funds in the Central Management Program by \$3.4 million for new and additional federal National Highway Traffic Safety Administration (NHTSA) grant awards the Department has received. Grant funding will be used for child safety, motorcycle safety, primary seatbelt safety and alcohol impaired driving programs.

Increase Infrastructure Engineering - Federal Funds, Page 98, Line 8 by \$3,000,000 from \$328,405,561 to \$331,405,561. The Governor recommends increasing federal funds in the Infrastructure Engineering Program based on an increase of \$2.5 million in federal funds for the Congestion Mitigation and Air Quality (CMAQ) Improvement program that is used to finance operational costs of the Department's transit program. In FY 2014, the Department of Transportation submitted a reduced CMAQ budget because at the time of development, federal requirements placed a three year limit on the use of CMAQ funding for operating purposes of transit. Since that time, the federal restrictions have been lifted and CMAQ funds can be used for operating expenditures without limitation. The Department uses these federal CMAQ funds for such things as monthly payments to AMTRAK for use of the main line and for preventive maintenance of tracks, insurance costs to indemnify AMTRAK and the MBTA, and all other operating costs of the South County commuter rail service including payments for operations of Wickford Station. Additionally, an increase of \$500,000 is needed to create a new clearing account related to funds the Department has received through the sale of property to the I-195 Redevelopment Commission. This account will act similar to the Department's GARVEE/Motor Fuel clearing account based on both sources coming from funds outside of the Intermodal Surface Transportation Fund found within the state accounting system.

### SECTION 4, FY 2014 FTE POSITION AUTHORIZATION

Page 101, Line 22: Increase the University of Rhode Island's third-party funds FTE authorization from 518.6 to 593.2, or an increase of 74.6 FTE positions. This amendment would restore the third-party funded FTE position authorization to the FY 2014 enacted level of 593.2 FTE positions. This change does not authorize additional FTE positions, but rather increases the number that can be supported by third-party funds within the overall authorization.

<u>Page 101, Line 28:</u> Increase the Community College of Rhode Island's third-party funds FTE authorization from 59.7 to 100.0, or an increase of 40.3 FTE positions. This amendment would restore the third-party funded FTE position authorization to the FY 2014 enacted level of 100.0 FTE positions. This change does not authorize additional FTE positions, but rather increases the number that can be supported by third-party funds within the overall authorization.

### INSERT NEW SECTION 6 AS SHOWN BELOW:

SECTION 6. Notwithstanding any general laws to the contrary, the Department of Administration shall transfer nine hundred twenty-five thousand, four hundred nineteen dollars (\$925,419) from the Restoration and Replacement - Insurance Coverage Restricted Receipt account to the State General Fund on or before June 30, 2014.
